The book first of all contains a collection of instructions and SOPs related to project registration and edit, ownership and liability of the project plot, registration extension, section 8 and 15 proposals, registration withdrawal, status of OC/CC of the project, maintenance of bank account related to the project, carpet area, etc. Similarly, there is a collection of instructions and SOPs related to filing a complaint in RERA. After that, instructions and SOPs related to hearing in the bench, their disposal and implementation of the passed orders, editing of complaints and disposal through conciliation forum have been collected.

Apart from this, notifications and orders related to registration, training and certification of agents and expansion and establishment and administrative system of the authority have been collected and presented at one place in the book.

On the occasion of the book release, Mr. Sanjay Bhusreddy, Chairman, UP RERA informed that this book compiles the instructions and SOPs issued by RERA from the day of its inception till 10.09.2024, which will benefit all stakeholders of the real estate sector.
